REMINDER: CHECK YOUR DATA

Checking your musical works data for accuracy is the most important thing you can do to ensure you receive all of the mechanical royalties that are owed to you.

The MLC encourages Members to regularly check their musical works data, especially as you begin to register new musical works. If you ever come across any errors, and you administer the work you can correct them yourself within the Portal or work with our Support Team to get them resolved.
