2. Mid-Tier Service

The Mid Tier Service will be a highly differentiated, limited catalogue, consumer subscription product. Mid-Tier subscribers will enjoy all of the content and features of the Ad-Supported Service, but without intrusive audio or display advertising. Subscribers will also be able to cache their favorite tracks and playlists on a temporary basis as Conditional Downloads, and will have access to exclusive content within the Mid-Tier Service, specific details of which have yet to be finalized.

3. Premium Service

The Premium Service will be a full catalogue consumer subscription product. The Premium Service will include all of the content, features and functionality of the Ad-Supported Service and the Mid-Tier Service, plus access to Premier Partners' full catalogue of content.
